Eligibility:

Open to any NPC athlete that is in good standing. Must have 2011 NPC Card. (2011 NPC cards will be available at weigh-ins August 12, 2011 for \$100.00) Teen, Masters competitors must have reached the age of the categories listed below on the day of contest. (Proof of age is required) Novice competitors are eligible only if they have never placed 1st-3rd in open class or 1st place Novice Division in any NPC sanctioned event. Contestants may enter more than one division, however, athletes will only pose once at the evening competition. To be eligible to compete in the New Mexico State division, you MUST provide proof of residency for at least 4 months prior to the contest.

Awards:

Mid USA & New Mexico - 1st – 5th in each Division. Men's and Women's Open Mid-USA Bodybuilding, Figure and Bikini Champions receive Overall Awards. Men's and Women's Open New Mexico State winners receive Overall Award.
